It's that time of year again! Below you will find important information regarding changes within the Approved Instructor Support Department. Please note the following changes and updates. Be sure to sign and return the 2010 Required Approved Instructor Sheet that is included with this packet. This is due by January 25, 2010.

#### Price Increase for ICISF Workbooks and Certificates:

Effective January 1, 2010 workbook prices will be increasing to \$15.00 USD. Certificates will increase to \$4.00 USD. This fee is a result of the increased fees charged to ICISF from our vendors. Any workbook and/or certificate orders <u>received</u> after January 1, 2010 will be charged the increased fee.

# ICISF Certificates to be Required for all ICISF Workshop Participants:

#### Workshop Returns:

#### **Evaluations**

Evaluations must be distributed to every workshop participants. Please be sure to order them with your workbooks and certificates

In order to scan the evaluations it is important that you not photocopy them should you run out. Each evaluation must have an individual bar code. However, these bar codes are NOT specific for each workshop. As such, you may reuse blank evaluations for future workshops.

- -Successfully completed the Changing Face workshop (either online or at an ICISF Regional Conference). We must have a copy of your certificate of completion on file.
